## Demurrage & Detention (DnD) Bulgaria Import Tariff Review

Dear Valued Customer,

In a continued effort to make it easier for our customers to do business with Hamburg Süd, we have reviewed the Demurrage and Detention (DnD) product effective from the 1st April 2021 for import cargo to all Bulgaria ports.

Plug in / Connection Charges will be charged separately as per local costs.

The period of demurrage will run from 00.01 hours on the day of discharge until the day on which the container is returned to the carrier's terminal empty.  
The period of freetime will run inclusive of Saturday/Sundays, weekend rest days & Official Holidays.  
All local taxes / VAT are for account of the receiver.

**SPECIAL EQUIPMENT** means the following types of container (20' and/or 40'): Open Top, Open Sides, Flat Racks, Flat Beds, Platforms, Insulated Dry Vans, Hangertainers, Bulkainers, Tank Containers, Pallet-wide Containers.
